### **Shelter and Transitional Living Program Story**

John, a white, 16-year-old boy, had a troubled and challenging life. John's father died when he was just 12 years old and, due to his serious drug addiction, John had no contact with his birth mother. So, he was shuffled around from family member to family member for years when he was younger, suffering from frequent abuse, neglect and abandonment. Because of the limited supervision he received, he found himself in and out of trouble. Committing petty theft and experimenting with drugs and alcohol caused him to be in and out of the Juvenile Detention Center and eventually placed in a program for troubled boys. Upon completion of that program, John found that he had nowhere to go, nowhere to sleep and no way to get food.

So, he came to Harbor House (the Shelter) for emergency services. John was shy and very reserved at first and didn't easily make friends. He was cautious with the information he shared with his counselor. His counselor worked at John's pace and slowly John opened up about the abuse and neglect he suffered. John shared that he aspired to be "different, good, successful and happy."

While John was living at Harbor House the staff was able to get him enrolled back into school. This was a first step toward his future. Just after getting enrolled, it was clear to the staff that John would not be going home with anyone, so he moved to the SHORE House to receive long-term services.

Through a supportive and caring environment, John worked diligently on his class work over the first marking period and to his surprise he made high honor roll. For the first time, he realized success and began to understand what it meant. He also began a summer job at a local fast food restaurant and opened a savings account to start saving for his future. As John's confidence and self-esteem soared, he began to make friends in the house and slowly became more outgoing.

John came home one day and stated that he would like to join the wrestling team. With no prior experience, he

gave 100% and never missed a practice. Not winning any matches initially, he persevered. By the end of the year, he was winning matches, gained respect from teammates and coaches, lettered in wrestling, and received the President's academic award for making high honor roll for four making periods.



Returning to say hello, John reported that he is now in college, has a car and job, and plans for his career. He casually told his counselor that if it weren't for Ocean's Harbor House, he truly believes he would be in jail or dead.

### **Outreach Story**

Emily met us hanging out, just passing time at the Ocean County Library, one of the main places the Street Works Outreach team goes to meet young people in need. Over the next 3 months, we began to see her around more and more. After getting to know her, she disclosed that her mother had passed away recently, leaving her and her sister with their father. Their father, who was left to raise a 14-year-old and an 8-year-old, was tormented by the loss, turned to alcohol and became distant, angry, hurtful and unable to cope. Emily was angry, scared and confused, but still, so full of life and energy. She finally decided she wanted to attend the Young Women's group that the agency held.

She attended the support group regularly for 4 years and became very connected to Ocean's Harbor House. She shared her grief at the loss of her mother, the anger at her father for not knowing how to raise two girls on his own, her frustrations and accomplishments at school, the good and the bad, until we watched her graduate. We were the ear to listen, and so often the shoulder she needed to cry on. There were times that she asked us to talk to her father and help them communicate and there were times when she would lose touch with us. Most of all we worked with her and taught her how to better communicate her

thoughts and feelings, how to stand up for herself, and how to work past the pain, grief and loss and to focus on her future.

Then came the day she left us, deciding that living in town was too painful. Young and in love with the wrong person, she was gone. Just simply gone. She went halfway across the country where she lost sight of her family, friends and us. We understood she wanted to go, to be free and independent at age 18, but we knew she wasn't ready. She finally contacted us, and kept contacting us while she was away - we told her we would always be there for her.

Six months later, in she walked, pale and skinny, with her beautiful eyes to the ground. Ashamed for leaving and for what she had done while she was gone, the staff immediately greeted her with a huge sigh of relief and the biggest hugs in the world.

Once again, she would be safe, drug free, and with people who would be able to help her move past the pain and the losses, and move forward in life.



## 2011 Program Highlights

In 2012, so far we have had 7 young people graduate from the Transitional Living Program, 5 went to college, 1 went to a vocational school and another is working. Two more young people graduated from high school while staying at the Emergency Youth Shelter.

## 16th Annual Harbor House 400

It was another amazing and successful year for the Harbor house 400 ride! The cyclists rode 403 miles this year, going from Barnegat, NJ to Chincoteague, Virginia and back to Brick, NJ.

In the early morning hours of July 10th, 45 bicycle riders and 16 support and gear people (SAG) left the parking lot of St. Mary's in Barnegat to begin the trek south to Chincoteague, VA. On Thursday, July 11th, 7 additional riders and 4 SAG joined this group there for the return leg of the trip to Windward Beach Park in Brick.



If you asked any one of these people to sum up the ride you would probably get the response, "enjoyable but flat." After which the riders would probably add, "But that headwind going into Chincoteague was tortuous."

Flat rides are good because there are no hills to struggle up, but flat rides also means there's no hills to coast down -which puts bicyclists in the position of having to pedal the entire time they're on their bicycle. A headwind is never any good -you can't anticipate its end like you can a hill as you're pedaling up it so you never know how long it's going to last.



Whether it's flat, hilly, headwinds or no headwinds, hot, humid, rainy doesn't really seem to matter to those who participate in the ride. If you asked any one of these people why they do

Each year we are provided many gifts that enable the agency to not only survive, but thrive. This past year was no exception and we would like to thank the following for their consistent commitment to assisting our homeless, runaway, abused, neglected and abandoned youth:

- **United Way of Ocean County** has assisted the young people of this community consistently through the years. This past year was no exception, and they provided Ocean's Harbor House with more than \$100,000 in funding for the houses and outreach program.
- The **New Jersey Department of Community Affairs** awarded us a Shelter Support grant once again for our Transitional Living program. An award of more than \$72,000 will enable us to purchase a new van, install a generator in case of power loss, and other necessary renovations to the house.

- The **OceanFirst Foundation** provided \$25,000 in some much needed funding for our Emergency Youth Shelter, to replace the hot water heater that broke and support our new programming with Project LEAP (Life Skills, Education, Advancement, and Prevention).
- **Open Arms and Extended Arms** once again worked hard throughout the year to help support our young people by throwing a variety of fundraising events on our behalf. At the end of the year, they presented a \$20,000 check to Ocean's Harbor House.
- **Lydia Collins deforest Charitable Trust** has once again provided a substantial and very necessary grant award of \$20,000 to go toward general operating expenses.
- The **Nordson Corporation Foundation** has supported our request for funding for our Transitional Living Program and awarded \$12,000 so that we can provide services and follow-up care to our young people.
- **James Gandolfini (Tony of "The Sopranos")** was generous enough to donate 13 laptop computers (over \$8,000 value) to replace the much older computer we had to help out the staff.
- **Wells Fargo** not only continued to provide their \$1,000 Community Partnership Grant to Ocean's Harbor House this year, but also awarded us a \$5,000 grant to help with the educational and employment development efforts of our young people.
